There were no Members' Declarations of Local Non-Pecuniary Interests and/or Disclosable Pecuniary Interest in subsequent Agenda items and no additions and/or deletions to the Council's Register of Interests.

- 6.1 After proof reading the Discover Suffolk leaflet more than once he had given approval for printing, and
- The changes to the Rights of Way Cutting Schedule had been forwarded to the County Council but the 2019 programme with the contractor had already been agreed.

19.04.07 **Noted**:

A written summary from the Clerk that

- 7.1 The Parish Council agreed new Cemetery Software which has been ordered and is scheduled for installation in May.
- 7.2 Revised fees and charges for the Cemetery have been published.
- 7.3 Following the Clerks correspondence with Memorial Social Centre with respect to the tree root, the work remained outstanding.
- 7.4 A complaint about fallen trees between Genesis Green and Lords Lane, which had been reported through Suffolk County Council website. The Chairman had visited the area and discussed the matter with the complainant. Ownership was unknown but it was believed that

- the area was unregistered common land, in which case Suffolk County Council may accept responsibility.
- 7.5 A complaint about damage to the right of way No.31 in the vicinity of Australia Farm, which has been reported through Suffolk County Council website. The complaint concerned regular use by horses but as this is one of the few bridleways in the Parish, Cllrs. felt that there was no further action that could be taken.
- 7.6 With thanks to Roger Merry for his research, that a gate closer had been purchased for the pocket park at Bury Road and it was hoped that it would be fitted in the near future.
