Conditions of use

1. This form is valid for five years from the date of signing. After this time, the consent will automatically expire and we will delete the images it relates to.
2. We will not include details or full names (which means first name and surname) of any child or adult in an image or video, in any digital or printed material without good reason. For example, we may include the full name of a competition prize winner if we have their consent. However, we will not include the full name of a model used in promotional literature.
3. If we use images of individual children, we will not use the name of that child in the accompanying text or photo caption without good reason. And if a child is named in the text, we will not use a photograph of that child to accompany the article without good reason.
4. We will not include personal email or postal addresses or telephone or fax numbers in any digital or printed material.
5. We will only use images of children who are suitably dressed.
6. Wickhambrook Parish Council reserves the right to share images taken at the event with West Suffolk Council for publicity purposes. West Suffolk Council agrees to the same conditions of use above.
