What I asked the Prime Minister during PMQs

Dear Resident

More than 30,000 people across the country, including many here in West Suffolk, were caught up in the infected blood scandal after being treated with contaminated products in the 1970s and 1980s. The last Conservative government promised full compensation for the victims after a public inquiry found the authorities covered up the scale of the problem.



However, this Government's regulations for the compensation scheme move the goalposts for victims — introducing new exclusions, treating victims inconsistently and reducing some previously-agreed awards. On Wednesday, I challenged the Prime Minister about it. As you can see by clicking here, he refused to listen.

Your voice in Parliament

On Tuesday, I gave a speech in the House of Commons on the Government's Schools Bill. Luddites in the Education Department are taking a hammer to the machinery that has made English schools the best in the West. If you would like to watch my speech, please click on the YouTube icon below.



As Nick Timothy MP said on 18 March 2025, the Government's new education legislation will lower the quality of education for children from working families.

On Monday I asked the Justice Minister, Sir Nicholas Dakin MP, about the sentencing guidelines that treat racial and religious minorities preferentially — and are due to come into effect on 1 April. I also raised the Equal Treatment Bench Book, which says, "to treat some persons equally, we must treat them differently". Shamefully, as you can see by clicking here, he abdicated responsibility.

Will Labour help businesses?

welcomed the chance to visit as many West Suffolk firms as I can. So it was brilliant to be able to sit down and listen to more than 20 local business leaders on March 7.

A wide array of businesses were

A wide array of businesses were represented, from a luxury hotel to a plastics manufacturer which has had a pioneering role in its sector.

We were lucky enough to have the head of the one of the last remaining family-controlled British shipping companies, alongside local pub landlords, farmers and manufacturers. We were also joined by the representatives of the Suffolk Chamber of Commerce and the

Eastern Powerhouse.
What emerged from our discussion was the seriousness with which businesses view the present environment. One manager said the situation was the very worst he had ever experienced.

ever experienced.

The wider context is that Britain's existing economic model is bust. Like



in many other Western countries, growth is sluggish, and wages stagmant. Our birth rate is declining, and immigration is rocketing.

Investment is low and productivity is poor. We have trade and budget deficits and a large stock of debt.

deficits and large stock of debt.
Many of those present felt that
Labour's French-style labour laws
will make it riskier and more
expensive for businesses to hire.
Others felt the increase in employer

National Insurance Contributions would hold back wages, lead to job losses and push up costs. Meanwhile, farmers are having to

Meanwhile, farmers are having to compete on an uneven playing field. They face an unreasonable burden of regulation that many overseas competitors, who also send food to British supermarkets, do not have to face.

As well as coping with the immoral family farms tax, too many farmers

are now forced to depend on sources of income not related to agriculture. They should be able to make a decent living growing British food. This benefits us all; food security is national security.

Ministers should support firms with incentives for training, research, plant and equipment, and with tax, regulation and planning policies that are favourable to

investment, growth and expansion.
One 'systemic challenge' raised was prohibitive business rates.
Others felt that incentives such as Research and Development (or R&D) tax credits were outdated. Although worth billions of pounds per year, businesses feel hamstrung because the Treasury makes it so difficult, and bureaucratically challenging, to make a claim.
Overburdensome red tape is now

Overburdensome red tape is now matched by reckless spending. In their manifesto Labour said they would increase spending by £9.5 billion a year. Yet, the Budget increased it by £76 billion a year — eight times more

This is what is behind the tax rises.
And what do we get in return?
Transport investment spending is
being reduced by 3.1 per cent. That
means fewer new roads and railway

means lever her values and raiway upgrades and poorer connectivity. Here in Suffolk, we are crying out for key infrastructure improvements — such as the dualling of the Newmarket to Cambridge train line, the Fiveways bypass, the Ely and Haughley junction upgrade, and a rail link between Haverhill and Cambridge, not least so we can get freight off our overburdened roads and onto railways.

and onto railways.

This is also important so residents and commuters can get quickly, smoothly and safely to their destinations.

We need a government that can be trusted to help support growth, boost food security and back enterprise.

Yet increasingly, West Suffolk's businesses feel they are being left out in the cold. This needs to change, and quickly.

The local media reported the fact that I sent a <u>detailed submission</u> to West Suffolk District Council to make the case for a new relief road and other traffic improvements in **Mildenhall** as the application for construction of 1,000 more houses is considered. I have also made the case for this to Suffolk County Council. A relief road and more investment are crucial to protect quality of life, keep vehicles moving and improve safety. Scrutinising the Government

During oral energy questions this week, I asked the Parliamentary Under-Secretary of State for Energy, Michael Shanks, to guarantee that our carbon price will remain lower than the European price for the remainder of this Parliament.

On 18 March 2025, Nick Timothy MP spoke from the Opposition despatch box in the House of Commons. He said the Government is planning to potentially triple the carbon price to European levels.

In a series of parliamentary questions (here, here, here and here), I asked the Government to give businesses more clarity on new regulations which oblige producers of products to bear the entire cost of recycling the packaging they place on the market. These new rules have the potential to seriously harm businesses in the East of England — with an impact on both turnover and prices — yet ministers still have not provided the details businesses need.
