Play Area Repairs, Maintenance and Replacement

The Estates Committee considered proposal for authorising the costs of play equipment supplies and remedial works arising from play inspections (WPC.EC.24.02.04) at its meeting on 1st February 2024 (Min. 24.02.09 refers). No amendments to the proposal were identified, but noting that the combined costs of the current and next financial year exceeed \pounds 3000, the meeting asked the clerk to refer the proposal to the parish council for consideration.

A summary of findings from the most recent West Suffolk Play Area inspections is attached as **Appendix A.**

The clerk also met with the inspector on the 7th February, and established that:

- In his view, the basket seat itself did not require replacement in the short to medium term
- The tree canopy should be trimmed back such that it is at least 2m from any play equipment at height

Following the October inspection, the clerk had sought costs for all replacement items such as chains, shackles, bushes, swing seats, bolt caps etc. and the quote received, from Online Playgrounds is attached as **Appendix B**. A further quote has now been received from GB Sports Limited (**Appendix C**) A summary setting out a proposed timescale of work is attached as **Appendix D**, identifying items for replacement and maintenance over the current and next financial years, to be included in the draft budget for 2025-26 and as part of any future grant application.

In February '23, the Committee authorised the costs of play equipment supplies

(WPC.EC.23.02.03) as below:

The Estates Committee authorise the clerk to purchase replacement equipment (including where necessary, the cost of fitting replacements) as identified under the monthly inspections undertaken in accordance with the service level agreement (low risk or greater) with West Suffolk Council during the financial year 2023/24 up to: (current spend shown in brackets

- i. Playground Cemetery Road £1000.00 plus VAT (£506.77 plus VAT)
- ii. Playground Bury Road £500.00 plus VAT
- iii. MUGA & Skate Park £500.00 plus VAT (490.00 plus VAT)

Leaving the following funds available for maintenance until year end:

- i. Playground Cemetery Road £493.23 plus VAT
- ii. Playground Bury Road £500.00 plus VAT
- iii. MUGA & Skate Park £ 10.00 plus VAT

Additionally, Online Playgrounds have issued a credit note (£100 plus VAT) to the parish council against an item of work in the previous financial year.

Work which the parish council could undertake as part of volunteer days includes:

- Repair of paling fence to Childrens Play Area at Cemetery Road and removal of concrete block
- Cleaning down of wood and metal play equipment at Cemetery Road and treatment for wood and metal
- Replacement of bin in MUGA space (there is one spare in the Chapel of Rest)

And the clerk has approached and obtained from the WI consent to access their water supply.

Hilary Workman Clerk & RFO February 2024 The clerk has split the quotes into 4 sections – spend from the current and next financial year, 2025/6, and purchases to be made if grant funding approved, as the total cost is beyond the parish council in any one year. Work to be completed in 2025-26 and any items to be purchased through grant funding, the clerk would seek additional and subsequent quotes for.

Thus, the proposal is to purchase consumable items in the current financial year (applying the credit note), and then purchase the remaining consumables and instruct the work in the next financial year (Online playgrounds have confirmed that they would be amenable to this approach). Replacement of the uprights for the bay swing seats at Bury Road would be budgeted for in 2025/26, and the replacement springers for cemetery road and basket seat would be included in any grant applications which become available.

This would be more expensive, because the suppliers would charge separately to come back in 2025/26 for replacement uprights. As the total cost for the current FY and work to be completed in the next FY is was originally anticipated to be over £3,000.00, in accordance with the Scheme of Delegation, approval for the overall scheme was referred to the parish council.

The relevant council powers are:

This approach would require either transferring between revenue budget lines in the next FY, or drawing down some earmarked reserves, both of which would require a decision by the parish council.

At its September meeting, the Estates Committee:

considered a draft proposal for future works to Six Acres, Cemetery Road play area, the Multi-Use Games Area, Skate-park and cable way, and Bury Road pocket park (previously circulated as **WPC.EC.22.09.03**), which could form the basis of grant applications for funding as they are published and asked the clerk to develop a template grant application on the basis of the works identified in the report (Min. EC.23.09.09).

At its September meeting, the parish council noted:

A proposal by the Estates Committee to develop an outline bid for Six Acres & play area improvements for grant funding (note report WPC.EC.23.09.04) and asked the clerk to develop a template grant application and plan for community engagement activities to gather evidence in support of all the elements. (Min. 23.09.16 refers)

A number of items identified in the proposed timescale for work at Appendix D could be included in this grant application, and a more detailed proposal-will be brought back to the April meeting.

Stanton Parish council are in the process of arranging play area inspection training, at an anticipated cost of £250 per person (including certification) and the clerk has expressed an interest in one place (there is currently a revenue budget of £756 for training).

GB Sports Limited have also advised that they provide some maintenance courses where the repair work is undertaken as part of the course, and materials (if not already purchased) would be invoiced after the course.

Actions

Items identified in the proposal (Appendix D) be included in

- a. the draft budget prepared for the financial year 2025-26; and
- b. the draft proposal for future works to parish amenity spaces
