

Draft 3 Year Plan

A summary of income and expenditure against budgets (to 28th October 2022) relevant to the Estates Committee is set out below:



Notes:

The majority of cemetery fee income falls in Quarters 3 & 4. Ground Rents invoiced and reminders sent. VAT claims are now submitted monthly (£5755.48 received to date) Recycling income is paid bi-annually (£1462.49 received and paid out for Oct `22 – March '23).



Notes

Grounds Contract expenditure profile skewed to 1st half of financial year. Unless there is a need for additional cuts over and above the spec in the remaining two months of the year (November and February), this should come in under budget (currently \pounds 8916 against a budget of \pounds 14,500).

Six Acres – £375 committed spend to replace rotting posts at Tennis Courts.

Tree surgery has been completed for this year and was £70 against a budget of £750.


Grounds Maintenance (general and parish days) – the first day in the current financial year to take place in November, leaving a further day for spring '24)

Playgrounds – Cemetery & Bury Road – 50% budget on Cemetery Road went to replace buffers on Monorail. Budget for Bury Road is likely to largely be allocated to replacement parts for swing sets.

MUGA, Skatepark & Cableway - retensioning of Cableway in September

A new parish noticeboard has been purchased (for installation in November).

The bus shelter is due for installation late autumn, funded from SCC Highways s.106 allocation from the Meadows Development.




Notes

The Senior Wooden Goal End came in very slightly under budget (\pounds 305.29). This underspend could be put towards repairing deterioration in concrete on the boundary or a replacement bin.

Parish Groundworks (Drainage) – work to drain the pond at Coltsfoot Green was completed this summer, and came in slightly under the adjusted budget (skip for waste - £350).

Some play equipment is requiring more maintenance and the parish council should now start building reserves for larger scale replacement of play equipment.



Notes:

There is an underspend on Electricity for Chapel of Rest – following a switch, a refund is due from E.onNext .

Summary:

The clerk has summarised projects and works to parish assets which have been identified by councillors and the clerk to address and has provisionally scored them in order to prioritise the work across the next 3 financial years, as the basis for a strategic plan for the committee (attached as **Appendix A**).

Provision in the work plan has been made for the following:

- Work to Trees at Chapel of Rest
- Replacement of play equipment (spinning pole) at Cemetery Road
- Fencing of play area(s) (to build into a grant application)
- Memorial testing and actions arising from this
- Financial support for Memorial Clock
- Cleaning of War Memorial & fitting of restraining wires

A draft budget based on works identified and scoring will then be included in the full report to the parish council's November meeting (subject to any changes proposed by the Committee on priorities and any further information on pricing the clerk receives).

Action:

Committee members are asked to discuss and agree spending priorities for the next financial year.
