# Play Area Inspection Reports & Remedial Work

A summary of findings from the most recent West Suffolk Play Area inspections is attached as Appendix A.

These reports were followed up with the inspector who has also been provided with a copy of the Test Certificate for the recent check and re-tensioning of the Cableway.

In addition:

- The clerk will ask for a quote to lift the tree canopy at Cemetery Road Play area when requesting quotes for work to trees following the Tri-annual inspection which took place on 3<sup>rd</sup> July.
- Play area inspections have been made available on google forms

Following the report WPC.EC.24.02.03, and the committee's approval of the proposed approach to undertake remedial works identified, and the parish council's authorisation of funds (Min. 24.02.14 refers), the clerk placed purchase orders for the items identified at Appendix D (then current FY and FY2024.25).

Online Playgrounds attended on site in early May and carried out the work. The total cost was:

 Parts ordered in 2023.24
 £ 628.90 plus VAT

 Parts and fitting in 2024.25
 £1999.25 plus VAT

 **E2628.15 plus VAT** against a budget of £3000

As part of the assessment(s), they identified:

- 1. The traveller break on the cable way required replacement (item could continue in use)
- 2. Work to replace pop rivets to the shelter in the skate park could not be undertaken, as the bench had twisted and would require fitting with bolts to bring into line;
- 3. A cost to fit end cap bolts etc to the climbing frame was provided.
- 4. The self closing gate at Bury Road will be re-calibrated free of charge

Additionally, the clerk identified from the inspector's report that chains and shackles would need to be supplied for the two bay swing set. A further quote was sought, and the clerk successfully negotiated a reduction on the call out to the cableway repair on the basis that the travelling break issue should have been reported and dealt with when they were on site.

A purchase order has therefore been submitted to address the matters identified at 1-3, and purchase and fitting of chains and shackles to the two-bay swing set, at a cost of  $\pounds$ 877.80<sup>1</sup> plus VAT (**Min 24.02.1iii**, and Appendix A refers).

Online playgrounds is expensive in terms of the costing for onsite attendance, and this places constraints on the frequency of work undertaken when issues are identified by the play inspector(s).

One option which considered by the clerk has been Sovereign Compliance (details attached as **Appendix B**), which includes:

- No monthly subscription. Only pay £399 for 5 years of cover, 2 inspections with reports per year
- Comprehensive safety and maintenance reports on both Sovereign and third-party equipment
- Essential maintenance and repairs included as standard
- Inspection of third party equipment as well as their own
- Two operational inspection visits per year
- Operational inspections by registered RPII Inspectors

Sovereign supplied the Senior Wooden Goal End in the Multi-use Games Area.

As the parish council already has free monthly inspections undertaken by a qualified inspector from West Suffolk, the main issue is actually the smaller ongoing maintenance and repair items and this may not represent value for money (dependent on the extent of the essential maintenance and repairs included as a standard).

Following networking, the clerk has been given contact details for an alternative supplier of maintenance and repairs of play equipment, with positive reports. The clerk has approached them for initial discussions and advice on some of the low risk issues identified in the inspectors report (repairs to surfaces and wet pour matting).

Before making a commitment to Sovereign, it is proposed that the clerk further explore working with this new supplier (dependant on costs), who also works for Suffolk CC Highways as a contractor on their Public Rights of Way.

<sup>&</sup>lt;sup>2</sup> The clerk will consider for future budgets allocating one revenue budget line for all play areas, as in order to save costs, the work is usually grouped together to reduce charges for attendance on site, and it can subsequently be hard to separate out the invoicing.
